- 2 recent Paystubs – for all borrowers dated within 30days of submitting the application
- W2's/1099's – Two years complete and signed copies of tax returns & copy of extension (if applicable)
- 2 months of recent Bank Statements – complete copies dated within 60days of submitting the application (All checking, savings, money market, retirement, etc.)
- Complete copy of Divorce Decree (if applicable)
- Complete copy of Bankruptcy Papers & Bankruptcy Discharge (if applicable)
- If receiving Child Support – need copies of receipts for proof of payment or print-out from Child Support Division Office
- Legible copy of your driver's license and social security card
- Existing Survey (if available)

SELF EMPLOYED
